

TERMS AND CONDITIONS FOR PARTICIPATION AT

THE GLOBAL URBAN AIR SUMMIT 2019 ("GUAS19")

1. General

With submission of your web booking You enter into a binding agreement ("Agreement") with Farnborough International Limited ("FIL") to participate in GUAS19 ("Event") managed by FIL based on these terms and conditions and any rules and regulations issued by FIL. Any other terms and conditions contained in any purchase order or proposed by You are not binding on FIL unless agreed by FIL in writing.

FIL reserves the right to refuse any booking without explanation.

2. Price

The total price ("**Price**") for participating in an Event is shown on the Event web page. VAT will be added to the Price at a prevailing rate.

3. Payment

You become liable for the full payment of the Price with the submission of Your booking.

Any additional or extra charges arising during the course of an Event and for which You are liable must be paid within 30 calendar days of the date of the FIL invoice for these charges.

4. Entry and Admission

No admission tickets, passes, itineraries, maps, exhibition stand allocations or other information required to attend or participate in the Event will be issued to You until full payment has been received by FIL. FIL reserves the right to refuse admission to any person or to remove persons from an Event without explanation.

5. Transfer

You cannot assign, sell or give Your rights to participate in the Event to a third party without written consent by FIL. If You are unable to participate, then you may nominate a substitute to attend at no extra charge providing You advise the GUAS19 team prior to 20th August 2019, after which date no substitution will be permitted.

6. Variations and Amendments

If You wish to vary or amend Your Application, You must notify FIL in writing as soon as possible. FIL will use reasonable endeavours to accommodate requests for change. You will be liable for any increase in Price arising from the variation or amendment.

If, for any reason, FIL has to change any of the arrangements relating to the Event it will inform You forthwith and use reasonable endeavours to minimise the impact of the changes. Please note that it may be necessary for reasons beyond FIL's control to change the contents and timings of the programme, the speakers, the date or the venue.

7. Cancellation

<u>Cancellation by FIL</u>: If, for any reason, it becomes necessary for FIL to cancel the Event, Your payment will be refunded less any costs reasonably incurred by FIL.

<u>Cancellation by You</u>: Once You have completed the booking/registration form and paid the Price, FIL will not make any refund in the event of Your cancellation.

8. Liability

FIL will not be liable in contract, tort or otherwise for any indirect or consequential losses including but not limited to loss of profit, loss of use, costs or expenses, or other claims whether caused by FIL, its employees, contractors or agents arising from You taking part in an Event.

Nothing in this Agreement excludes or limits the liability of either Party for: death or personal injury caused by negligence or any other liability which cannot lawfully be excluded or limited.

The liability of FIL to You for all claims in aggregate arising from Your participation in the Event shall not exceed the fees paid by You under this Agreement.

10. Indemnity

You shall indemnify, and keep FIL indemnified, against any loss or damage suffered by FIL arising from any negligent or deliberate act by You, Your employees, servants or agents in connection with the Event especially when it caused personal injury or damage to property.

11. Business Ethics and Anti-Bribery

You and Your employees, agents, servants or otherwise shall at all times in connection with the Event comply with anti-bribery and other ethical standards set out in Common Industry Standards for European Aerospace and Defence issued by the AeroSpace and Defence Industries Association of Europe, copies of which are available at <u>www.asd-europe.org</u>.

12. Hazardous Goods

You shall not bring any item or substance to the Event which is dangerous or whose movement or use is forbidden by the local laws.

13. Data Protection

Any personal data supplied in the Application will be used by FIL and any contractor appointed by FIL solely for the purpose of facilitating the booking. Any personal data provided may be processed outside of the territory of the European Union.

FIL may take photographs and/or videographic recordings of attendees at GUAS19 and may use such for marketing purposes.

14. Rights of Third Parties

No term of this Agreement shall be enforceable under the Contracts (Rights of Third Parties) Act 1999 by a person who is not a party to this Agreement.

15. Applicable Law

This Agreement is governed and construed in accordance with English law and the Parties submit to the exclusive jurisdiction of the English courts.
